## Management Forest Law Order Update

In early March the Ruses Condominium Association approved a contract with Rolefson Forestry Services. John Rolefson will provide the services to mark and harvest timber (61 acres) as outlined in the Managed Forest Law Plan. His first responsibility is to mark the desired trees and provide a required DNR Cutting Notice. Our hope is that this activity will begin in late April. Owners and guests hiking the trails should use caution during this process while some trails will be closed for safety.
